BACKGROUND:
Summary

On January 20, 2015, the Economic Development Agency (EDA) advertised a Request for Qualifications (RFQ) for pre-qualifying consulting services. The RFQ included various consultant services including materials testing and inspection, geotechnical, and environmental consulting services. The RFQ's were submitted for the purpose of developing a pool of pre-qualified consultants to perform project work on an as-needed basis.

BACKGROUND:

Summary (Continued)

Creating a list of pre-qualified consulting firms is in conformance with Board Policy H-7 and is intended to enable EDA to quickly respond to client needs and accelerate the delivery of several active capital projects that are progressing towards the construction phase. In accordance with the policy, the period of qualification for the selected firms will remain in effect for a maximum of three years from the date of Board approval.

Per Board Policy H-7, a selection committee was established to review each firm's qualifications. After reviewing the submitted qualifications, 20 firms were selected for materials testing and inspection; 24 firms were selected for geotechnical consulting; and 19 firms were selected for environmental consulting services. Each firm offers particular strengths that may apply to different types of projects.

The consulting services will be retained on an as-needed basis via the issuance of a contract or purchase order for negotiated services including, but not limited to, agreement on the scope of work, terms, conditions, and funding availability. The consultant services fees will not exceed \$100,000 per project and in accordance with Board Policy B-22 any project with a total budget estimated to exceed \$100,000 will be subject to the requirements of the Capital Improvement Program.
