**AIR:** Ontario International Airport (owned and operated by Los Angeles World Airports), 45 mi. northwest, is served by AeroMexico, Alaska, America West, America Airlines, Continental, Delta Airlines, Frontier, jetBlue Airlines, Lineas Aereas Azteca, Northwest, Southwest Airlines, United Airlines, and United Express. Hemet-Ryan Airport (County-owned) has general aviation facilities, 4,315 ft. runway. A runway expansion is planned. The California Department of Forestry and Fire Protection is based at the airport.

BUS: RTA bus to Riverside, Sun City, and Perris.

PORTS: Ports at Los Angeles-Long Beach, 95 mi. west, and San Diego, 92 mi. south.

**HIGHWAYS:** Calif. 74 east-west and Calif. 79 north-south. Connections 12 mi. west to I-215 north-south, and 13 mi. north to Calif. 60 west and I-10 east-west.

Industrial Sites	There are approximately 1,075 acres in the city zoned for light and heavy manufacturing. About 65% is vacant and available in various size parcels. The terrain is level. Drainage is fair. Subsoil is sandy loam, and piling is not required. Sizes of water mains range from 8 to 14 inches. Sizes of sewer lines range from 8 to 24 inches.
	Description of sites on or off rail lines, zoned for industry, outside the city limits in other tracts or districts: there are approximately 290 acres between the cities of Hemet and San Jacinto zoned for light manufacturing. About 60 percent is vacant. The area is served by a Burlington Northern Santa Fe branch line. There are 54 acres at Hemet-Ryan Airport available for aviation related development and are zoned M-2. A Burlington Northern Santa Fe branch line serves the property. There are approximately 150 acres zoned for heavy manufacturing north of Hemet-Ryan Airport and south of State Highway 79. Two new industrial parks coming to the airport area: a 20-acre park and a 60-acre park with rail. **Extent of Unionization:** Generally restricted to the building trades, retail clerks employed by supermarket chains, and culinary workers who work for larger restaurants.

**OTHER:** The local economy is based on trade, service and agriculture, primarily geared to the needs of a growing population of retired citizens, with above average retirement incomes, and young families, and manufacturing - especially mobile homes and recreational vehicles. An abundant supply of labor is usually available, particularly for all skill levels.

**HEALTH:** Hemet has 1 acute care hospital, with a 453 total bed capacity, 152 physicians/surgeons, 51 dentists, 15 optometrists, 25 chiropractors, and 6 podiatrists.

**EDUCATION:** Hemet Unified School District includes 11 elementary schools, 3 middle schools, 2 high schools, 1 continuation high school, 1 K-12 school, 1 alternative high school, and 1 community day school. Seven private schools are located in Hemet.

**CULTURAL:** 72 churches, 3 libraries, 2 newspapers, 2 theaters, with 13 screens, 4 radio stations, 1 TV cable system, 8 banks, 9 savings and loans, 8 parks, and 4 playgrounds. Other recreational facilities include: Ramona Bowl Music Association, Hemet Community College Concert Association, Mt. San Jacinto College cultural presentations, Ramona Bowl, where the outdoor play "Ramona" is given annually, and Hemet Valley Art Association.

The median sales price for new and existing homes is \$207,500, according to the California Association of Realtors First Quarter 2004 Report. Three and four bedroom house rentals range from \$795 to \$1,295 per month. One and two bedroom apartment rentals range from \$450 to \$795 per month.

There are 13 motels, with 609 rooms, in Hemet. There are also 52 mobile home and RV parks in the city, with 6,984 mobile home spaces and 1,943 RV spaces.

Hemet is well known throughout Southern California as a retirement community. However, the same features, which made this area a retirement hot spot, are now attracting younger families as well. The community growth has lead to renewed expansion and prosperity to Hemet. As the west coast center for mobile home and recreational vehicle manufacturing, Hemet is an economic spark in the mid-County region. The City of Hemet is located in the center of a highly productive agricultural area and is the principal gateway to the San Jacinto Mountains recreational area. The community population supports an active and growing retail sector. At present, there are five major shopping malls to choose from and a myriad of local retail stores. Hemet is home for the nationally renowned Ramona Pageant, an annual outdoor cultural event, depicting the early life of the Hemet Valley. Hemet is also the home to the Diamond Valley Lake, which is the largest reservoir in Southern California. There will be over 22,500 acres of recreational opportunities, which will make Hemet desirable as a recreational destination in addition to enhancing local lifestyles.
